Elder –Elders (3 classes, 6 members each) are responsible for overseeing the life and ministry of the Church and form a group called the Session, moderated by the Pastor. Much of the work of the Session is done through councils, which include Adult Ministry, Children and Family, Congregational Care, Communication, Educational Ministry, Evangelism, Outreach, Personnel, Stewardship, Worship and Youth and Young Adult. Generally, Elders chair councils and participate in council work along with members of the congregation. The Nominating Committee will nominate six members for the office of Elder.

Deacon – The Board of Deacons consists of 3 classes, 12 members each. The Associate Pastor serves with the Board in an advisory role. The office of Deacon, as set forth in Scripture, is one of sympathy, witness and service after the example of Jesus Christ. Deacons minister to those who are in need, to the sick, the friendless and to any who may be in distress both within and beyond the community of faith.

Trustee – The Trustees (3 classes, 4 members each) at MPC are responsible for the operation and upkeep of the church, grounds and buildings, investment of funds and the annual budget. The board elects a president and secretary and is advised by the Pastor and the Finance Committee.

Officer Nominating Committee – the Officer Nominating Committee is composed of fourteen members including nine representatives selected from the congregation at large. This committee is charged with preparing a slate of church officers representative of the diversity of the Church. The slate of officers is voted on by the congregation at the Annual Meeting.
